Constitution

The Charity is a Scottish Charitable Incorporated Organisation

Organisational Structure

West Stormont Woodland Group Board, which includes the the charity's trustees, is responsible for the day to day running of the SCIO and controlling and recording all financial transactions. Trustees are elected at the annual genaral meeting and at any one time there must be between a minimum of 3 and a maximum of 10 trustees.

Charitable Purpose

The SCIO has been formed to benefit the community of people living in or registered to vote in the postcode areas of PH1 3, PH1 4 and PH8 0 surrounding Taymount and Five Mile Woods within the boundary defined therein by West Stormont Woodland Group with the following purposes:

The advancement of environmental protection or improvement.

The provision of recreational facilities or the organisation of recreational activities with the object of improving the conditions of life for the persons for whom they are primarily intended.

The advancement of citizenship and community development.

Any other purpose that may reasonably be regarded as analogous to any of the preceeding purposes.

Activities and Achievements

Activities increased significantly during 2023 with community events and woodland activities.

In response to recommendations from the CATS Panel in which a phased approach to woodland acquisition and reduced scale of proposed operations was agreed with Forestry and Land Scotland, WSWG submitted a revised asset transfer request for Taymount Wood which was approved in October 2023. The agreement was based on retaining the option to buy Five Mile Wood during a period of up to five years following the transfer of Taymount Wood.

WSWG's focus then moved to fundraising for purchase and 2 year start-up costs for the approved project. A key challenge arose when an application for 50% funding from the Scottish Land Fund (SLF) was unexpectedly rejected in March 2024 in a highly competitive and over-subscribed funding round. A full review of the funding strategy includes the possibility of resubmitting an improved application to SLF later in 2024.

Reserves

At the end of the period total reserves held at the bank and in cash were £16,519.

Independent Examiner's Report to the Trustees of West Stormont Woodland Group

I report on the financial statements of the charity for the period ended 31 March 2024, which are set out on pages 4 to 5.

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). Basis of Independent Examiner's Statement
